INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 341-Representative Yates.

To enact section 901.80 of the Revised Code to create the Livestock Care Standards Board and to require the Board to adopt rules that establish standards of care for livestock and poultry, including rules that prohibit specified practices.

H. B. No. 342-Representative Yates.

To amend sections 1151.23 and 1161.29 and to enact sections 1109.051, 1109.052, 1151.232, 1151.233, 1161.291, 1161.292, 1733.245, and 1733.246 of the Revised Code to limit overdraft fees chargeable by financial institutions and to establish certain requirements for overdraft protection services.

H. B. No. 343-Representative Schneider.

To require the Director of Administrative Services to conduct a study of potential operating efficiencies in state government.
